

THE CORPORATION OF THE TOWN OF WHITBY

BY-LAW NO. 5609-05

BEING A BY-LAW TO AMEND BY-LAW NO. 4910-01 REGULATING PARKING IN MUNICIPAL
PARKING LOTS

WHEREAS, Subsection 11(2) of the Municipal Act, S.O. 2001, c. 25, as amended, provides that a lower-tier municipality may pass by-laws respecting parking in municipal parking lots;

AND WHEREAS, the Council of the Corporation of the Town of Whitby has passed By-law No. 4910-01 to establish municipal parking lots on certain lands owned by the Town of Whitby and to regulate the parking of vehicles on such lands;

AND WHEREAS, the Council of the said Corporation considers it desirable to amend the fine provisions of By-law No. 4910-01;

NOW THEREFORE, the Council of the Corporation of the Town of Whitby enacts as follows:

GENERAL

1. Subsection 6(1) of Municipal Parking Lot By-law No. 4910-01 is revoked in its entirety and the following substituted therefore:

6(1) Any person who contravenes any of the provisions of this by-law is guilty of an offence and upon conviction, where a penalty for the offence is not otherwise provided, is liable to a fine of not less than \$10.00 and not more than \$300.00, excluding costs, recoverable under the Provincial Offences Act.

REPEAL OF EXISTING BY-LAWS

2. By-law No. 5186-03 is repealed.

EFFECTIVE DATE

3. The provisions of this by-law shall come into force and take effect on the day of the final passing thereof.

BY-LAW READ A FIRST, SECOND AND THIRD TIME AND FINALLY PASSED THIS 25TH DAY OF APRIL, A.D., 2005.


PROVINCIAL OFFENCES ACT

NOTE: The general penalty provision for the offence listed above is Section 61 of the Provincial Offences Act, R.S.O. 1990, c.P.33
