

# Town of Whitby By-law # 6918-14

## Traffic By-law Amendment

Being a By-law to amend By-law # 1862-85, known as the Traffic By-law, to create time-limited drop-off/pick-up vehicle zones and taxicab stands in Whitby.

Whereas pursuant to subsection 11(3) of the Municipal Act, 2001, S.O. 2001 a lower-tier municipality may pass by-laws respecting highways, including parking and traffic on highways; and

Whereas the Council of The Corporation of the Town of Whitby considers it necessary and desirable to create time-limited drop-off/pick-up vehicle zones and taxicab stands in downtown Whitby.

Now therefore, the Council of The Corporation of the Town of Whitby hereby enacts as follows:

### 1. General

- 1.1 That subsection 1(2)36. of By-law # 1862-85 be deleted and be replaced with the following;

"taxicab stand" means a part of a highway designated by an authorized sign where taxicabs, being motor vehicles that are kept or used for hire for the conveyance of goods or passengers and that are licensed by the Town of Whitby as taxicabs, may stop to take on or discharge passengers;

- 1.2 That Schedule A, No Stopping, And Schedule B, No Parking, are hereby amended as described in Schedule A hereto attached.


### 2. Effective Date

- 2.1. The provisions of this by-law shall come into force and take effect on the passing thereof and at such time as properly worded signs have been erected.


